Yet in academic discussions, the imaginative representations of these sites tend to be neglected in favor of spaces more overtly relevant to religious and political debates. To fill this gap, Grumberg proposes a new understanding of how Israeli identity is mapped onto the spaces it inhabits. She demonstrates that in the writing of many Israeli novelists even mundane sites often have significant ideological implications. Exploring a wide range of authors, from Amos Oz to Orly Castel-Bloom, Grumberg argues that literary depictions of vernacular places play a profound and often unidentified role in serving or resisting ideology.
